



# Buckinghamshire Country Parks Digital Annual Parking Permit Conditions of Use

Income generated from the sale of parking permits goes into the management, upkeep, and development of the Country Parks. Please read the information below carefully, if you have any queries or problems regarding Digital Permits then please contact the Country Parks Office, [countryparks@buckinghamshire.gov.uk](mailto:countryparks@buckinghamshire.gov.uk) If you have received a Penalty Charge Notice (PCN) please use the contact details provided on the notice itself.

1. Digital Permits are valid for use in: Black Park Country Park, Langley Park Country Park and Denham Country Park.
2. Each Digital Permit is valid to park one registered vehicle at any one time. You can register a maximum of two vehicle registrations to your Digital Permit, providing they are registered with the DVLA to the address you have used to set up your MiPermit account.
3. We reserve the right to carry out random checks to ensure all vehicles are registered to the same address.
4. Please select the vehicle registration of the car you will be parking via the MiPermit website/App by logging onto your account. Only the registration selected on your MiPermit account will be valid to park
5. If you plan to park more than one car at the same time at Buckinghamshire Country Parks, you will either need to buy multiple Digital Permits or buy Day Tickets for the additional vehicle(s)
6. Any amendments made on your MiPermit website/App account are immediately active.
7. If you need to update your vehicle registration number, please log onto your online MiPermit account and amend your vehicle details. There is no administration charge for this and is immediately active.
8. You may receive a Penalty Charge Notice if your selected vehicle registration details on your MiPermit account do not match the vehicle parked
9. No refunds will be made for a partial year.
10. Digital Permits cannot be transferred to a third party.
11. Digital Permits are only valid with the data you supply; please ensure you provide accurate and up-to-date information.
12. Please renew Digital Permits in good time, an automated renewal reminder will be emailed to the email address on your MiPermit account. If you allow your Digital Permit to expire before you renew you will be expected to pay and display until you renew your Digital Permit.
13. If you choose not to supply a valid email address, you will not receive automated confirmation of purchase or renewal reminder emails
14. You may be issued with a Penalty Charge Notice if you are parked causing an obstruction even with a valid Digital Permit.
15. You have a responsibility to use Buckinghamshire Country Parks (i.e. a public space) in a way so as to not cause disturbance by way of anti-social behaviour to staff, any other users of the park and the wider community, and not cause lawful users of the park to fear for their safety, the safety of a child, the safety of their dogs, the safety of livestock and the protection of wildlife. We reserve the right to cancel a Digital Parking Permit without refund should any of the above occur.
16. We will only contact you with Country Parks' news and events via email if you opt in on your application. This information is held securely; we do not and will not sell or pass this information to anyone else. If you no longer wish to receive this information, please logon to your MiPermit account and amend your records accordingly.
17. Permits are issued for personal/private use only, they do not in any way act as a license to carryout any commercial activity in the Country Parks.
