1. Introduction

- 1.1. By participating in the competition you are agreeing to these competition terms and conditions. The competition is being run by Buckinghamshire Council.

2. Eligibility to Enter

- 2.1. The competition is open to entrants of all ages. If the winner is under 18 years of age, their parent/guardian will be invited to accompany the winner at the official opening event. One parking permit will be allocated to the winner's registered parent/guardian.
- 2.2. The competition is open to all to enter, including Buckinghamshire Council employee and all affiliated groups.
- 2.3. There is a limit of one entry per person and the competition is completely free to enter.

3. How to Enter

- 3.1. Building name suggestion, plus entrants full name and postal address to submitted via email to: countryparks@buckinghamshire.gov.uk
- 3.2. Entries will be open from Monday 11 November 2024 till Sunday 5 January 2025. The winner will be announced on Monday 27th January 2025. No entries after 5 January 2025 will be included.

4. The Prize

- 4.1. The winning prize will be one parking permit for Buckinghamshire Country Parks, including Black Park Country Parks, Langley Park Country Park and Denham Country Park. This prize is non-transferrable and will be valid from one year from the date of registration.
- 4.2. You and a guest of your choosing will be invited to the VIP grand opening of the new café, the date is yet to be confirmed. This prize is non-transferrable, and the event date will be decided by Buckinghamshire Council

5. Terms and Conditions of the Prize

- 5.1. Use of the permit will be under Buckinghamshire Council's standard permit terms and conditions which are available to view on our [website](#).

- 5.2. The winner we need to provide full name, address, contact email and vehicle registration for the permit to be claimed. This information will be processed following Buckinghamshire Council's GDPR guidelines and the Data Protection Act 2015, and will only be used for the purposes of providing a parking permit.
- 5.3. The permit will not be valid until confirmation is sent to the winner. Full terms and conditions regarding Buckinghamshire Council's annual permits can be found on our [website](#).
- 5.4. The permit prize does not give any exclusive rights to a parking space or access to the park.
- 5.5. If the winner is an existing permit holder this can be used to extend your current permit.
- 5.6. We reserve the right to substitute prizes of equal or greater value if circumstances beyond our control require doing so.
- 5.7. Buckinghamshire Council's decision on any aspect of the competition is final and binding, and no correspondence will be entered into about it.

6. Winner announcement

- 6.1. The winner will be chosen by a panel of judges who will review all entries and vote on a winner. The panel will be made up of representatives chosen by Buckinghamshire Council.
- 6.2. The winner will be notified via email address provided on 27 January 2025.
- 6.3. Buckinghamshire Council will make two attempts to contact the winner via email.
- 6.4. If the winner does not respond to the emails informing them of their win within 7 days of the second email, they forfeit their right to the prize and Buckinghamshire Council reserve the right to use the chosen name.

7. Delivery of the Prize

- 7.1. The annual permit will be confirmed via email once it is live and validated on MiPermit's virtual permit system.
- 7.2. The VIP launch event invitation will be sent via email once a date is confirmed. The winner will need to RSVP and provide details of their chosen guest.

8. Competition Terms and Conditions

- 8.1. By entering this competition all participants will be deemed to have accepted and be bound by the Terms and Conditions. Participants should retain a copy for their information.
- 8.2. This prize competition is not gambling and therefore does not need a licence as it falls outside the remit of the Gambling Commission.

Incomplete, illegible, invalid, or misdirected entries, entries received outside any promotional period, entries by macros or other automated means (including systems which can be programmed to enter), and entries which do not satisfy the requirements of these Terms and Conditions in full will be disqualified and will not be counted.
- 8.6. All entrants will be required to provide a genuine email address that is personal, valid, and accessible throughout the promotion. In the event that the specified information is not provided or is incorrect or an alias, the entry may be considered incomplete and therefore the Promoter reserves the right to invalidate the entry. Buckinghamshire Council cannot be held responsible for winners failing to supply accurate information which affects prize acceptance or delivery of their prize.

By taking part in the competition, the prize winner agrees that Buckinghamshire Council may contact them to ask whether they want to participate in marketing activities relating to this competition only.
